2. Information We Collect

a) Information You Voluntarily Provide

b) Automatically Collected Information

Essential cookies are required for core functionality. Non-essential cookies are used only where permitted by law. You may disable cookies through your browser settings; however, some features may not function properly.

4. Embedded & Third-Party Content

5. How We Use Information

We use collected information to:

- Comply with legal obligations

We do **not** sell or rent personal data.

6. Data Retention

Comments and related metadata may be retained indefinitely unless removal is requested.
